## *Social Security Bill - Scotland*



The Scottish Government is planning to make changes to the Benefits system in Scotland.

FAIR helped make an Easy Read guide to the bill, setting out the changes the Scottish Government wants to make.

Members of the Scottish Parliament and other organisations will have the chance to look at the Bill and say what they think about it. The Bill is not expected to become law in Scotland until May 2018.

## *Supported Decision-making*

People First (Scotland) have been campaigning for equal rights for people with learning disabilities for a long time. Guardianship orders take away a person's right to make their own decisions.

People First has written a Framework for Supported Decision-making that shows that supported decision-making can work for everyone if it replaces the current Guardianship system in Scotland.

## *New transitions project from Contact A Family Scotland*

A new project is under way to close the information gap around leaving school and next steps for parents and carers of young people living with learning difficulties and/or disabilities.

Contact A Family wants to hear from families across Scotland supporting young people aged from 12 to 20. Their input will shape a new resource to better prepare families for the journey to adulthood.



Starting in September, families will be able to share their thoughts, questions and experiences through regional workshops, online discussion groups, or directly by email or telephone. Wherever possible, one-to-one conversations will be offered using alternative communication styles, for example Talking Mats or BSL, so as many people as possible have the chance to contribute their views and ideas.

The project is supported by the Scottish Government through a CYPFEIF and ALEC Fund grant.
